11. Copy of child's Social Security card
(not mandatory although recommended for potential, future Hope Scholarship identification)
12. Proof of Residency: (chose one of the following three options)
 - A. Lease, rental agreement or rent receipt consisting of written evidence that the agreement is valid and current **AND** a current utility bill (gas, electric, water, home telephone or cable TV). No cell phone bills, please. Records must include the name and street address of the parent/guardian.
 - B. A current residential property tax statement or deed **AND** a current utility bill (see above).
 - C. A third person affidavit of residency signed and notarized (valid for thirty days, if temporary) **AND (A)** lease or rental agreement consisting of written evidence that the agreement is valid and current **AND** a current utility bill **OR (B)** current residential property tax statement or deed **AND** current utility bill. Records must include the name and address of the third person signee.
