1. Marietta City Schools Magnet Application
2. Marietta City Schools Registration Form
3. Most recent report card or transcript from last school attended. GPA must be 3.0 or higher. History of satisfactory behavior and attendance required.
4. Parent Magnet Contract
5. Proof of residency (choose A, B, or C).
 - A. Lease, rental agreement or rent receipt consisting of written evidence that the agreement is valid and current **AND** a current utility bill (gas, electric, water, home telephone or cable TV). Do not submit a cell phone bill. Records must include the name and street address of the parent/guardian.
 - B. A current residential property tax statement or deed **AND** a current utility bill (see above).
 - C. A third person affidavit of residency signed and notarized (valid for thirty days, if temporary) **AND (A)** lease or rental agreement consisting of written evidence that the agreement is valid and current **AND** a current utility bill **OR (B)** current residential property tax statement or deed **AND** current utility bill. Records must include the name and address of the third person signee.

In addition to the documents above, **out of district applicants** must submit the following:

1. Birth Certificate (copy acceptable)
2. Hearing, Dental and Screening Certificate (GA form 3300)
3. Certificate of Immunization (GA form 3231)
4. Social Security Card
5. Non Resident Student Enrollment Application Contract
6. *Preferred - Copy of most recent nationally normed standardized test scores (e.g. ITBS, MAP, CAT, Stanford-10) for both reading and math (total for each must be in the 75 percentile or above to meet qualification requirements. If you do not have these scores, please let us know.*
